In the United Kingdom. 67. 95. 93.Wyoming Ag Stays Firm on Corn after Summer Rains With corn prices on the rebound this week following a record-setting U.S. crop, Nebraska's cash corn futures are looking attractive for growers. "We've certainly been moving the markets in the last 24 hours," said Kerry Logan, an analyst at Texas-based CME Group, Inc. On Wednesday, the Kansas City-based market-maker started to offer cash corn for December delivery at \$5.75 per bushel on the Chicago Board of Trade. That's up about \$1.20 in the past week and will likely return to that level when CME resumes trading on Friday morning. "The Kansas City CME futures market has become a little bit more active in corn than in recent weeks," Mr. Logan said in an interview. On Thursday, the cash price fell to \$5.55, according to a price survey of traders from the Kansas City Board of Trade. Importers, for the most part, have been increasing their purchases of Kansas City cash corn throughout this summer. But traders say they won't let total supply outrun demand too much unless the price keeps dropping to levels that aren't profitable. "We want to keep supply at a certain level," said Mr. Logan. "It's not enough to be an overwhelming influence on prices, but we'd like it to be the factor." "You'd like it to be a \$6 corn market," he said.
